**CONTRACT SPECIFICATION**

**4. Contract description**

Movimento Africa70 ETS ONG, in consortium with the Italian NGO CISP, acting as lead partner, is implementing an emergency project in the Sahrawi refugee camps. The overall objective is to help mitigate the impact of emergencies on the lives of Sahrawi refugees by strengthening their recovery capacity through inclusive education, improved healthcare, and food security.

Within this multisectoral intervention, Movimento Africa70 ETS ONG is directly responsible for implementing the following activities:

Health Sector

Activities related to Result 2.1 – Improved basic healthcare services in Wilaya of Aaiún and Dajla

- Activity 2.1.1 Rehabilitation of water supply and sanitation facilities in 6 medical dispensaries in the Wilaya of Aaiún, including basic equipment provision and supplies for the Central Pharmacy.

#### **5. Eligibility of tenderers and origin of the supplies**

No restrictions in terms of nationality of the contractors or origin of the supplies.

#### **6. Number of tenders**

No more than one tender can be submitted by a natural or legal person whatever the form of participation (as leader or member of a consortium submitting a tender). In the event that a natural or legal person submits more than one tender, all tenders in which that person has participated will be excluded.

The tenderer may submit a tender for one lot only, several lots or all of the lots, but only one tender per lot. Contracts will be awarded lot by lot and each lot will form a separate contract.

#### **7. Grounds for exclusion**

Tenderer included in the lists of EU restrictive measures (see [EU Sanctions map](#)) at the moment

## **SELECTION AND AWARD CRITERIA**

### **11. Selection criteria<sup>2</sup>**

The following selection criteria will be applied to the tenderers. In the case of tenders submitted by a consortium, these selection criteria will be applied to the consortium as a whole if not specified otherwise.

#### Professional and technical capacity of the tenderer

The objective of this criteria is to examine whether or not the tenderer (i.e. the consortium as a whole, in the case of a tenderer from a consortium):

- has sufficient expertise and experience to be able to handle the proposed contract.

The selection criteria for each tenderer are as follows:

The tenderer must have successfully completed at least **two (2) contracts of a similar nature and of a value equal to or higher than the amount of the offer submitted**, during the last twelve (12) months.

### **16. Alteration or withdrawal of tenders**

### **17. Operational language**

All written communications for this tender procedure and contract must be in English.
